**Ethics Line** – Confidential advice for members with questions about their own prospective conduct from WSBA Professional Responsibility Counsel. Call the Ethics Line at 206-727-8284. We also offer ethics resources such as WSBA Advisory Opinions and ethics education presentations for members statewide.

**Legal Lunchbox™ Series** – Fulfill your MCLE requirements by attending these free 1.5 credit CLEs which normally occur on the last Tuesday of each month at noon. The seminar topics focus on skills, tools, and techniques necessary in 21st century law practice and offer a complete range of MCLE credits.

In addition to the Legal Lunchbox programming, three free ethics credits are offered live and on-demand.

**Legal Research Tool** – Free access to Fastcase®, an online platform for legal research.
