Information and Discussion: Additional information about plans and options for the July 2020 Bar exam and relevant admissions and licensing rules is presented for the Board's review and discussion.

I have been monitoring information as it becomes available through various listserves and email exchanges. From this information, I have complied the two attached documents. These documents are summaries of information available until 5:00 p.m. on April 15, 2020, only, and the information could change at any time.

I make no representation that these documents are 100% accurate or that they fully represent the decisions or (particularly) the rules of every individual jurisdiction; for instance, I did not perform a separate scan of jurisdictions' rules to determine whether they have a "graduate practice" rule, but simply used the information provided in response to a survey. And some jurisdictions may have adopted some modifications to their rules to provide for longer post-graduation periods of practice before taking a Bar examination.

Despite these limitations, the Board might find the attached information of interest in its discussion.
