WHEREAS, the Administrative Office of the Courts, hereafter AOC, is responsible for providing information technology and services to all courts in Washington. These services are critical for the orderly and accurate processing of court cases and as AOC has been offline since November 4, 2024, and the courts necessary programs for the administration of justice and to hold hearings has been compromised or eliminated.

WHEREAS, the date for restoration of the required services has not been determined, now,

Therefore,

IT IS HEREBY ORDERED, EFFECTIVE IMMEDIATELY, Emergency Order 25700-B-720 issued by Chief Justice Gonzalez and the Washington Supreme Court on November 8, 2024 is adopted herein in its entirety.

CRIMINAL CASES:

CrRJ 2.1 (c) (2): This rule identifies citation filing within two days. Due to SECTOR-ETP (AOC) limitations, all citations filed through SECTOR by law enforcement are unable to be filed with the court. This rule is temporarily suspended until systems are restored.

The court will require the city prosecutor to file a criminal complaint for all person in-custody on new charges. The court will allow citations pulled from the back-office of SECTOR issued with a court date by law enforcement to be filed. The prosecutor is responsible for providing probable cause information to the court, counsel and the attorney of the day, contemporaneous with the filing of a complaint

CrRLJ 4.1 (a): This rule identifies time for arraignments. Due to SECTOR-ETP (AOC) and system outage, delays in filing and setting arraignments dates exist. This rule is temporarily suspended until systems are restored.

SENTENCING WITH MANDATORY MINIMUM PROVISIONS:


These sentencing cases are hereby suspended, until such time as records become available online to the parties.

INFRACTION CASES:

IRLJ 2.2 (d): This rule identifies citation filing within five days of issuance. Due to SECTOR-ETP (AOC) limitations, all citations filed through SECTOR by law enforcement are unable to be filed with the court. This rule is temporarily suspended until systems are restored.

IRLJ 2.6 (a) (2), 2.6 (b) (2) This rule identifies the time the court shall send a written notice to the defendant for a hearing as 21 days. Due to the system outage and diminished ability to schedule hearings this rule is temporarily suspended until systems are restored.
