

## 2016 Legislative Session Report

---

### Overview

The Washington State Bar Association (WSBA) participates in the legislative process in a variety of ways. In addition to sponsoring legislation, WSBA monitors legislative proposals introduced by members of the Legislature regarding statewide public policy issues.

After determining if a legislative proposal meets [General Rule \(GR\) 12.1](#), a WSBA entity may determine further action is needed. In accordance with the [WSBA Legislation and Court Rule Comment Policy](#), WSBA entities may comment publicly regarding a legislative proposal after approval of at least 75 percent of their executive committee and final approval by the Board of Governors (BOG) Legislative Committee. Commenting publicly may include testimony before a legislative committee or submitting written materials to members of the Legislature.

### 2016 Session Summary

The 2016 legislative session adjourned March 29 following a 20-day special session and 60-day regular session. Gov. Inslee signed a [supplemental operating budget](#) that increased state spending by \$211 million and included funding for the Administrative Office of the Courts as well as the Office of Civil Legal Aid. Additional funding was allocated to repair wildfire damage, address statewide homelessness and services for mental health.

Legislators also passed [supplemental transportation and capital budgets](#) that made minor modifications for the remainder of this fiscal year.

### WSBA-Request Legislation

The BOG approved the sponsorship of one Bar-request bill in November 2015. Originating from the Corporate Act Revisions Committee of the Business Law Section, [Senate Bill 6205](#) modifies the definition of an acquiring person for corporations who publicly trade in Washington with dual class stock structures. This statutory change provided clarification within Washington's Corporate Act (RCW 23B. 19).

[SB 6205](#) passed the full Legislature this session and Gov. Inslee signed it into law.

### Non-WSBA Request Legislation

WSBA Legislative Affairs referred approximately [326](#) bills to WSBA entities during the 2016 session. The referral of these non-WSBA request bills resulted in various internal stakeholders participating in legislative hearings, meetings, and other efforts to ensure bills either reached

final passage or were tabled for further consideration. These efforts were based on analyses conducted by WSBA entities in collaboration with the WSBA Legislative Affairs Manager.

After conducting a GR 12.1 analysis, WSBA entities elected to take the following positions for bills referred:

- Support;
- Oppose;
- Neutral; or
- Concerns.

In addition to taking a position on bills referred, WSBA entities also identified a priority:

- High;
- Medium;
- Low; or
- Monitoring.

This information assisted with relevant legislative strategy and subsequent legislative activity throughout session that included collaboration with legislators, staff, and other relevant organizations across the state. ## **Legislative Interim**

With the close of the legislative session, lawmakers have begun to consider legislation for the next session. Over the remainder of 2016, legislators will study public policy issues for introduction during the 2017 session. WSBA Legislative Affairs and relevant WSBA entities will monitor and participate in these discussions with legislators and various stakeholders regarding potential legislative proposals.
