1	3.O. Implementation of Standards.
2	Standard 3 shall be implemented in phases and shall go into effect on July 2, 2025, with the exception
3	of the paragraph of Standard 3.K applicable to appellate caseloads, which shall go into effect upon
4	adoption by the WSBA Board of Governors. The 2024 revisions to these Indigent Defense Standards
5	shall be implemented on the following schedule:
6	Until July 2, 2025 January 1, 2026, the caseload standards as adopted in pre-existing WSBA Standards
7	of Indigent Defense Services and Court Rule Standards of Indigent Defense shall apply: The caseload
8	of a full-time public defense attorney or assigned counsel shall not exceed the following:
9	150 Felonies per attorney per year;
10	300 Misdemeanor cases per attorney per year or, in jurisdictions that have not adopted a
11	numerical case weighting system as described in this Standard, 400 cases per year;
12	250 Juvenile Offender cases per attorney per year.

14	Phase 1:
15	Beginning July 2, 2025 January 1, 2026, within the twelve months following, each full-time felony
16	attorney shall be assigned cases constituting no more than 110 felony case credits and each full-time
17	misdemeanor attorney shall be assigned cases constituting no more than 280 misdemeanor case
18	credits. Beginning July 2, 2025, family defense attorneys shall not represent more than 45 family
19	defense clients or carry more than 60 open and active cases at any given time.

22	Beginning July 2, 2026 January 1, 2027, within the twelve months following, each full-time felony
23	attorney shall be assigned cases constituting no more than 90 felony case credits and each full-time

6	Beginning July 2, 2027 January 1, 2028, and for any twelve-month period following, each full-time
7	felony attorney shall be assigned cases constituting no more than 47 felony case credits and each full-
8	time misdemeanor attorney shall be assigned cases constituting no more than 120 misdemeanor case
