1) Minutes

The August minutes were approved without edits.

2) Office of Public Defense Update

Joanne reported that OPD had a statewide conference for the Parents Representation Program with 230 people in attendance. Today and tomorrow are the final days of the Trial Academies in Spokane and they will give out about 30 certificates. The Court asked OPD to synthesize the comments from the CPD regarding the Standards audit along with OPD's recommendations, noting who should be responsible for taking action. That will be completed the following week but it appears that the recommendations are in harmony with each other.

3) Spokane County Public Defender's Office

Daryl reported on the issue addressed in the news article that was included in the meeting materials. Spokane County is considering a switch to a nonprofit or other model other than a county run public defense office in order to address huge caseloads and other obstacles that have led to a lack of consistency in providing casework and individuals being held pretrial for a significant amount of time. Daryl asked if the Council could discuss the issues in light of the Standards and provide feedback to the County Commissioners in Spokane. The Council had a discussion. Justin shared background information about caseload issues in the Spokane area on both the city and county side. Members expressed agreement that it is appropriate for the CPD to reach out to the Commissioners and offer their expertise on this matter. Various Council members might engage in conversations with people in Spokane around this issue.

4) CrR 4.1/3.3 and CrRLJ 3.2.1

Daryl summarized the background information about the CrR 3.3 rules proposal that the CPD had submitted and the Court's subsequent rejection of the proposal. The materials included follow up information from the individual who suggested the original rule change and his continued efforts effect change. Kathy provided

information about what happened in Snohomish County relating to the issue, largely dealing with pretrial incarceration and other defense issues. The issue remains unchanged. Daryl asked if the Council had ideas on what to do next to address the underlying issues. There was agreement to gather more information and continue the conversation. Eileen will ask Judge Kessler for his thoughts, and Daryl will ask Justice Johnson for feedback on the rule proposal that was previously submitted.

4) Washington Defender Association Update

Christie reported that WDA has been conducting trainings, including a four-day training with the National Association of Public Defenders. They've hosted webinars on traffic violations and DUIs and have upcoming in person CLEs on mental health advocacy and the annual ethics CLE. WDA continues to work on a fiscal note analysis and they are looking at additional funding from the state. They are moving forward on a failure to appear bill that is moving and are participating in a coalition addressing at ICE in courthouses.

5) Committee Updates

<u>Standards</u> – Bob had submitted a written report for the materials. Eileen added that additional conversations have been taking place. They are in consensus that before submitting case load standards they first need to develop performance guidelines. Once the performance guidelines are completed, the Committee will circle back to the standards. The Council discussed the need for the guidelines and the standards. The Council also discussed broader issues with resource limitations in following the Standards and potential new standards, such as adequate staffing and qualification requirements.

<u>Independence Committee</u> – Sophia reported that the Committee has not been meeting actively lately but will continue to find time to meet. They are looking at updating standards, creating new standards, and a proposed court rule.

<u>Public Defense Structure</u> – Eileen reported that they are gathering information from OPD via their evaluation forms. Katrin is helping to gather the information and present it back to the Committee. Once they have the information, the Committee will review staffing levels and other infrastructure needs.

<u>Pre-Trial Reform</u> – Justin reported that the CPD has submitted the Public Defense Packet to the BOG for their approval. Jaime is presenting to the BOG on September 27th. WDA is ready to help distribute the packet after the BOG gives their approval. The Council had a discussion about the issues being addressed by the packet.

LFO Reform – Daryl noted that the Committee's chair, Nick Allen, is on sabbatical and asked for a brief conversation on next steps for the Committee. Daryl asked if the Committee should be suspended until Nick returns. Eileen noted that LFO reconsideration days are happening around the state and suggested the Committee look at those days to see if there is a model or roadmap that other counties could use. Judge Henke shared about the planning for the Pierce County event coming up. There was also a suggestion to continue to receive updates on what is happening regarding LFOs around the state. Jaime reported that an LFO consortium has been meeting and a report is being drafted that will summarize the data and work that's been done on LFOs. She will see if recommendations will be included in the report. There is also a court rule that a judge is working on that the CPD might be able to weigh in on. Other problems include DWLS3 issues, debt collectors and a mandatory a \$500 assessment fee when data shows most people cannot afford to pay that. There is a lot of work going in this area. Instead of suspending the Committee, a better next step should be to review the LFO workgroup report (chaired by Justice Yu) and then come back together in October when Nick returns from sabbatical.

6) WSBA Structures Workgroup

Eileen referenced the report and the minority report, which is in the materials. She noted the minority report she and Hunter Abel wrote. The materials were sent to the Court for their September 4th meeting and now we are

awaiting a response from the Court. No longer need to make updates on this for future meetings. The Council discussed the issue that legislation is still alive to repeal the bar act and will be addressed at the start of the next session.

7) WSBA Updates

Diana reported that there are staffing transitions in our department. Diana will be taking over the Diversity, Equity and Inclusion portfolio work in addition to the access to justice team, which staff the Council, Access to Justice Board and pro bono and public service activities.

Daryl noted that he has been in conversations with members of the ATJ Board about projects to look at bridging the civil/criminal divide. He has also been in discussions with the VLP group in Snohomish about models where civil legal attorneys are housed in public defense offices and establishing best practices. Diana noted that Francis Adewale is asking the ATJ Board to put together a workgroup to discuss civil/criminal issues. She invited people to come to the October 11 ATJ Board meeting to provide thoughts.

8) Announcements

Daryl reported on CPD membership changes starting in October. The next meeting on October 4th will include an orientation.

Eileen reported that on November 15th there is an interpreter training.

Sophia reported that the DSHS is launching a tool to review if someone is receiving state benefits. Sophia will send a one pager to Bonnie to distribute to the Council.

The meeting adjourned at 2:07pm

Dear Chief Justice Fairhurst:

This letter is in response to your letter of September 13, asking the Office of Public Defense (OPD) to respond to comments submitted by the Washington State Bar Association's Council on Public Defense (CPD) regarding the 2019 Audit of Trial-Level Compliance With The Standards For Indigent Defense. As you requested, the table below presents OPD's response to each CPD comment and identifies a recommended action and responsible entity.

In addition, in the process of discussing the CPD comments, OPD managing attorneys recommend two priorities: Make the Standards for Indigent Defense mandatory; and establish an enforcement process. Implementation of these two recommendations will effectively address several of the issues identified in the Audit and in the CPD comments.
