FY2027 LLLT Board Appointment Recommendations

The Board discussed the FY2027 LLLT Board appointment recommendations for member and chair positions. The application window initially opened May 1 – 31, and now will remain open through the end of June 2026. For Board term starting 10/1/2026 and ending 9/30/29, the Board has a total of 3 board member positions to fill, of which 1 will need to be an active LLLT and 2 need to be active WSBA members (either LLLT, LPO, or lawyer).

The Board approved a motion to put the recommendation of FY2027 Board members and Chair on the next LLLT Board agenda or vote by email after June 30, 2026, once all applications received.
