Project Updates

The Board is working with WSBA staff to get this posted. The current draft will be posted on Box for Board review and input.

Jeremy Burke and Dr. June Darling have been tasked with revising the Board's **UPL Complaint Form** and revising it to gather better information. Chair Cherry suggested to look at other jurisdictions' complaint forms. The Board discussed having the revised UPL complaint form translated.

Data-Driven Legal Regulatory Reform

The Board sent the <u>recommendation</u> on Data-Driven Legal Regulatory Reform to the Court on January 3, 2023. The Board sent a follow-up letter to the Court on January 19, 2023, requesting permission to draft further materials for the DDLRR. The Court will discuss this project with the WSBA Board of Governors at their annual meeting on March 3, 2023. Chair Cherry will attend this meeting with the Court and BOG. Chair Cherry will present to the BOG on March 4, 2023.

Craig Shank offered to assist Chair Cherry in attending meetings with other jurisdictions on legal innovation.

Legal Checkup

Chair Cherry and WSBA are working on translation contracts. The Board reviewed the flowchart for the ChatBot. Chair Cherry requested that a public member review this language. Ellen Reed and David Sattler will review this. Governor Jordan Couch and Assistant General Counsel Thea Jennings will also review the language.
