

PRO BONO AND PUBLIC SERVICE COMMITTEE MEETING MINUTES

RPC 6.5 Updates

Bonnies shared that this was a proposal that came up last year; goal is to amend RPC 6.5 to allow QLSPs to serve potentially conflicted clients so long as they provide notice. Intent of this change is to give notice to parties at intake rather than when conflict arises, because this could put DV survivors at risk of notifying their abusers that they are seeking legal assistance. CPE was in support of the goal of the proposal, but disagreed with some of the language. CPE worked with the Pro Bono Council to make some revisions. Draft proposal is attached to the materials: includes revision to the rule and supplemental comment.

ACTION: Bonnie moved that PBPSC submit a comment in support that will go before the Board of Governors for final approval. Paul seconded. Unanimous approval.

Nick shared that ATJ Board is considering a letter. Nick and Yuan will be meeting with KCBA's legislative committee to get support from KCBA.

Paige will be sending Denise the proposed rule for a possible letter in support.

CLE Workgroup

Nick shared that Brendan has been coordinating with Professor Kim Hyde Pearson from Gonzaga University and will be presenting at the October Legal Lunchbox. We are still looking for one more presenter.

Technology Workgroup
