Membership Demographic Study Report & Updates

Dr. Ben Kim-Gervey shared an overview of the membership survey findings and provided a status update on the membership study process. Ben also offered some recommendations based on the data:

- 2. Enhancing diversity mentorship programs particularly helping people navigate specific career pathways
- 3. Promoting issue education, particularly among leaders and potential allies that are largely unaware of the negative daily experiences
