JUSTICE IN POLICING ACT 2020

Attached is the proposed Justice in Policing Act. (This draft was received 6/7/2020)

Section 102 is the QI provision. This bill does a LOT more

Let me know what I can do to support your efforts. I will be sharing it with the Labor and Employment Law Section's Ex Comm leadership. We're meeting in another week or two and I'll be bringing up how we can address these issues for our members. Should be an interesting discussion, especially with the labor issues.

I also just went to the WSBA site to look for a past CLE we did on police and communities of color in 2017. I could not find the webinar on WSBA's CLE site, which is a bummer because, although it is 3 years old, it still has relevance. I know Fred is still on the section, so if you are interested, he can tell you more as he and Alec Stephens coordinated it. I'm attaching the flier.

(After seeing a notice about an upcoming CRLS CLE that I hadn't received notice about, I realized it is because I did not renew my section membership in Jan when funds were tight. I just renewed it! My apologies for that oversight.)

Also, I sent someone from the NLG to you as a contact as they are going to be doing training and need help on defense of protestors. It doesn't look like people use the listserv much, so I'll continue to direct folks to you so you can review information and determine whether it should be posted to the CRLS listserv (or if there is someone else you prefer I direct things to let me know).

Along those same lines, I received the WA Supreme Court's message from a colleague. I don't often use the court's site and would have missed it otherwise.
