WELCOME, ANNOUNCEMENTS AND MINUTES

10/30/2020 Retreat Meeting Minutes.

Mike moved that the meeting minutes from the 10/30/2020 Executive Committee Retreat be approved. and **Sage** seconded. The 10/30/20 Retreat meeting minutes were approved.

TREASURER'S REPORT

Matt reported that we have not received new FY 2019-2020 reports, or any FY 2020-2021 reports or figures.

GRANTS UPDATE/REPORT

Patrick reported that he, Ron and Meredith will be meeting prior to our December Committee meeting to discuss the rotation of the Elder Law Internship between the three law schools and the Section's financial contribution to the internship stipend.

Patrick reported that reached out to representatives at Seattle University and University of Washington law schools regarding the average summer non-profit internship stipend amount and to-date has learned that the average is \$5,500 - \$6,000. The Elder Law Internship stipend is currently \$6,000.

OUTREACH & MENTORSHIP UPDATE/REPORT

Mike reported that he will be a speaker and/or faculty member of the certified professional guardian 2021 certification training program which the AOC is helping to facilitate. The 2021 program, approved by the CPGB, is an alternative to the UW CPG training course which is on hiatus this year.

CLE UPDATE/REPORT
