Marques Lang, a section member joined us.

Kari Petrasek joined us as BOG liaison.

Public Comment: No public comment.

Legislative update: Meeting with Senator Phil Fortunato this past week. SB 5858-plain and simple bad law. The last part of their meeting was about rewriting some parts and would be giving us a new draft by Thursday, so FLEC could vote by Friday. Pat let it be known that FLEC would not be supporting the bill because it is bad law. It doesn't look like 5858 will make it out of committee. (a non-exhaustive list for a fair/equitable division of property)

SB 5859: Proposing studying the use of separate judges to determine parenting plans and property distribution in marriage dissolution cases. This idea is flawed in a number of different ways. The parenting plan and property divisions. You can't come up with a parenting plan in a vacuum. As far as a study is concerned, he doesn't believe we should take a position.

GR 12: Any opposed? Meets GR 12.

Pat moves that FLEC not take a position on this bill. Kim seconds Pat's motion. Vote: Beth and LaVonna abstain. Motion passes.

SB 5861: Another Senator Fortunato bill. This bill has a number of different requested changes, some of the changes are stacked together. An amendment to the contempt statute, concerning procedures and evidence in civil actions involving domestic relations and protection orders. This is a "it's not broke and doesn't need to be fixed." Also, the bill proposes that the court could modify a support order in a contempt hearing.

Bo joined us at 9:35am.

Discussion regarding how best to discuss legislative issues in a public meeting.

**BOG Report**: From Nancy and Kari. There was a report from Judge Chung from the Superior Court judges Association. There are 200 judges and 75 commissioners, 75% have less than five years of experience. There seems to be a change from people wanting to end their career on the bench and those using the bench as a career steppingstone.

The new President of Kirsten Ferara, in April of the Superior Court Judges Association

Last year there were 15,000 section members, FLEC was approximately a 1,000 of those membership.

The current per member charge is \$18.73. The remaining \$11.27 goes to the section itself.

\$100,000 in scholarships and grants.

Sections are active. (section/membership review)

A member wellness task force has been started. They are seeking volunteers to sit on the task force. We may want to consider having a FLEC member on the task force.

There is going to be a new Civil Needs Study that the Access to Justice is working on. This will give us an accounting for what the state needs on unmet legal matters.

An issue came up with the LLLT meeting, they had a form of for parties to sign regarding equalizing property. Raises a concern about whether we should have a say in the forms that they draft. We should consider whether FLEC should be involved in reviewing the forms or having a say.

The biggest issue the WSBA is dealing with is licensure. Washington is considering eliminating the bar exam. Oregon is eliminating its bar exam. Nancy suggested having BOG Jordan Couch come to a future meeting and talking with us about this issue. Couch has been very involved in this.

There are some issues, that committee made some recommendations that went to the Supreme Court. Nancy believes we should be prepared to respond at some point. The law clerk program has been very active in this process. Couch has research that shows bar exam passage does not make you a great lawyer.

**STAR update from Kari**: Discussed legal interns in rural deserts. Student loan forgiveness for lawyers who work in rural areas.

5861: Went into executive session to discuss SB 5861.

5861: This bill shouldn't pass as a whole; it needs to be broken up. There is one part that Pat feels we should get behind. 9.73 two changes to RCW 9.73 allows one sided recording in a CPO so long as it is used within a year.

Pat moves 2237-moves that FLEC supports this bill as drafted with the exception that the language "if the parents agree."

With respect 5861, Pat moves to oppose this bill only in the sense that it is omnibus. Jackie seconded the motion. Beth and La Vonna abstain. Motion passes.

Pat moves that he be authorized to communicate with Senator Fortunato those sections of SB 5861 that FLEC would support, to include the RCW 11.76.110 and 26.09.170 in the context of the *Ross* case. Laura seconds the motion. Beth and La Vonna abstain. Bo abstains. Motion passes.
