I. CALL TO ORDER

Chair Drew called the meeting to order at 12:03 p.m.

II. ROLL CALL

PRESENT

Andrew Pollom, Chair Dillon Speiss, Chair-Elect Greggory Busch, Secretary/Treasurer Shona Voelckers, At-Large Member Andrew Fuller, At-Large Member Jessica Roberts, At-Large Member Daniel Rey-Bear, At-Large Member Brenda George, Immediate Past Chair

Meeting Quorum: A majority of the thirteen (13) voting executive committee membership constitutes a quorum

needed for action, which is a total of seven (7) or more voting members.

* Indicate non-voting member

III. APPROVAL OF MEETING MINUTES

Motion to approve of November meeting minutes, with changes made by Daniel Rey-Bear, passed unanimously.

IV. FINANCIAL UPDATE

Chair Drew discussed changes to budget since last update. August – September changes to budget: ILS has agreed to sponsor the food portion of happy hour for Indian law Symposium via a \$1000 donation in September.

Updated balance of funds is \$96,246.43

WSBA liaison Carolyn discussed accounting practices of WSBA sections; there is an adjustment to the budget each year in September and October to account for fiscal year vs. membership year. The adjustment is to deposit money into ILS section for the members that have joined and paid dues during the membership year. Carolyn is available if any members have questions about this process.

v. SUBCOMMITTEE REPORTS

1. CLE Subcommittee

Chair Drew gave report from CLE subcommittee. The CLE Subcommittee recommended to hold annual Indian Law CLE on May 15-16 based off of overwhelming choice from surveyed ILS membership as well as Stokes Lawrence confirming availability on those days.

Questions before the Executive Committee are: (1) Whether to hold CLE April 10-11, or May 15-16; and (2) at what location?

- No discussion on what date. Motion to adopt ILS CLE committee recommendation of May 15-16 made by Daniel, Seconded by Shona Voelkers. Motion passes unanimously.
- (2) Location of CLE: Discussion by Executive Committee. Chair Drew stated that Seattle University and Tulalip Tribe responded favorably to potential of being hosts. Tulalip has two potential rooms available, but no word on costs yet. Potential in-kind donation for this location from Tulalip tribal prosecutor or Reservation Attorney.

Member At-Large Shona stated there was no current response from Yakama Nation; will follow up. Shona's preference is to move CLE outside of Seattle, ideally in Indian Country. If Tribes are open to hosting CLE, then ILS should be open to locating with them.

Secretary/Treasurer Gregg stated that his preference is to try something new with the CLE location, and accepting a Tribe's invitation to host would show respect.

Member At-Large Andrew made **MOTION** to authorize Chair Drew to work with Stokes Lawrence as sponsor for the CLE with Tulalip as 1st choice for host, while recognizing that Stokes may not be able to commit; this motion gives Drew discretion to work with Stokes Lawrence at either Seattle University or Tulalip. Motion Seconded by Shona.

Motion Discussion:

Secretary/Treasurer Gregg expressed desire to avoid situation where Tulalip believes ILS wants to locate CLE with them, but we cannot commit. Stressed importance of clear communication.

Immediate Past Chair Brenda supports giving Chair Drew discretion to proceed with CLE location.

Member At-Large Daniel addressed that while there is a potential risk of speakers not showing up at Tulalip due to location being less convenient, but that speakers in Indian Country should be used to traveling to Indian Country, so this risk is mitigated. Member At-Large Shona stated that all speakers she is talking to will need to travel, regardless of location, due to being in Central WA. Member At-Large Andrew stated that there is a significant risk that he cannot speak at the CLE personally, if it is hosted by Tulalip.

Vote: Motion passes unanimously.

2. Mentorship Subcommittee

Chair Drew summary of subcommittee meeting: discussed quarterly meeting with Native children to introduce Indian Law practitioners; Ogden Murphy Wallace wants to host in February-March. Potential for unbudgeted funds (\$4,000 "reception expenses" is available). Reception expenses can be retroactive if needed, but if there is a contract, WSBA needs advance notice and has to be signor.

Member At-Large Jessica Roberts: asked what subjects NALSA would prefer, such as resume writing, interview prep, and application/scholarships. Encouraged exploration of topics.

3. Communications Subcommittee

Chair Drew summary of survey of responses for newsletter: 5 responses so far (2 of which are Drew) for topics.

Option: Once speakers are recruited, perhaps we can put together something out for fall 2025. 3 people are interested in writing, plus Drew.

Member At-Large Andrew asked a question for Drew about outdated web site comments on the newsletter. Spring 2020, 2019 era "if you are interested in submitting, Jeremy wood" at outdated e-mail. Action item for subcommittee is to update this section.

VI. OLD BUSINESS

1. Holiday Party

At Alibi Room tonight (December 12, 2024). Looking forward to seeing members attend.

2. <u>Scholarship Outreach Update</u>

- Unbudgeted funds were approved by WSBA use
- Gonzaga, UW, SU all excited for scholarship funds outreach
- Also reached out to Bree Black Horse and Derek R. at Heritage University; have been contacted by Drew for their allocation of \$10,000. Heritage U and NW Indian College will need at beginning part of 2025.
- Lummi NW Indian College also contacted by Drew.

VII. NEW BUSINESS

Chair drew acknowledged that it is on his list to confirm with WSBA staff whether to address unexcused absences to address it, conform with bylaws, or amend allow bylaws to allow at different date? In meantime, Gregg to remove "excused" absences from meeting minutes.



Jessica Roberts: Earlier this year, the Washington State Attorney General's Office Tribal Policy team created an Indian boarding school legal subcommittee to look at what recommendations the advisory committee could put in its report about what the State can do to start to address the harm done by boarding schools here in WA. The State has specifically allocated funds to this project in its 2024 and 2025 budgets. Myself and a couple of other subcommittee members would like to present about (1) the legislation underlying our committee's efforts, (2) our findings with respect to historical legislation and policies regarding Indian boarding schools here in WA, (3) truth and reconciliation models we have looked to, (4) efforts to link any current actors to liability, and (5) our accomplished and anticipated action steps.

Topics That Were Discussed But Not Selected:

- Colville-Teck Litigation: 9th Circuit brief on cultural resource damages appeal; Paul Dayton and Lexi are interested in discussing
- Indian Status for MCA purposes (Drew added ideas for TWA panel)
- Threats of clawing back unexpended funds

- Crystal Hill-Pennington: Disaster sovereignty and the argument for recognition of Tribal law and Tribal Corporations as eligible for Public Assistance under the Stafford Act and FEMA policy.
- Derril Jordan: This session address abuses of railroad rights- of-way over Indian reservations. It will focus on strategies that tribes and Indian landowners can use for holding railroads and federal agencies like the Surface Transportation Board and the Bureau of Indian Affairs accountable in respecting their treaty and statutory rights under federal law.

INDIAN LAW SECTION

Bylaws

As last amended and approved by the WSBA Board of Governors on November 16, 2017.

ARTICLE 1. Identification

1.1 <u>**Creation**</u>. The Indian Law Section of the Washington State Bar Association (the "Section") is established pursuant to the Bylaws of the Washington State Bar Association (the "Bar").

1.2 **Jurisdiction**. The jurisdiction of the Section shall be all aspects of Indian Law.

1.2 <u>Purpose</u>. The purpose of the Section shall be to seek the participation of all interested members of the Bar, and of county and local bar associations, in order to benefit such members, their clients and the general public:

- By providing the opportunity for exchange of ideas in the area of Indian law; to further the development of this area of the law; to communicate useful information pertaining to Indian law to members of the Bar; and to improve the application of justice in this field, all in conformity with the Bylaws of the Bar.
- (b) By initiating and implementing common projects.
- (c) By review of pending legislation and development of proposed statutory enactments to improve and to facilitate the administration of justice within the Section's area of interest.
- (d) By undertaking such other service as may be of benefit to the members, the legal profession and the public.

1.4 <u>Limitations</u>. These bylaws have been adopted subject to the applicable Washington Rules of Court and the Bylaws of the Bar.

1.5 **Principal Office**. The principal office of the Section shall be maintained in the offices of the Bar.

1.6 **Fiscal Year**. The fiscal year of the Section shall coincide with that of the Bar.

Indian Law Section

ARTICLE 2. Membership

2.1 <u>Enrollment</u>. Any Active member in good standing of the Bar may be enrolled as a member of the Section upon request and payment of annual Section dues in the amount and for the purpose approved by the Board of Governors of the Bar. In accordance with the Bylaws of the Bar, law students may be enrolled as non-voting members ("subscribers") of the Section. Subscribers may not hold a section office.

2.2 **The Membership**. Members enrolled as provided in Section 2.1 shall constitute the membership of the Section.

2.3 <u>Dues</u>. Dues shall be in the amount determined by the executive committee and approved by the Bar's Board of Governors and shall be paid annually in advance. Dues for law students shall be a standard annual amount set by the Bar's Board of Governors. Any person who shall have failed to pay the annual dues shall cease to be a member of the Section.

ARTICLE 3. Meetings of the Membership

3.1 <u>Annual Meeting</u>. The annual meeting, of the Section shall be held in conjunction with the WSBA Indian Law Section CLE.

3.2 <u>Quorum</u>. The members of the Section present at any meeting shall constitute a quorum for the transaction of business.

3.3 <u>Controlling Vote</u>. Action of the Section shall be by majority vote of the members present.

3.4 **Special Meetings**. Special meetings of the membership of the Section may be called by any officer at such time and place as the officers may determine.

ARTICLE 4. The Executive Committee

4.1 <u>**Powers and Duties**</u>. The executive committee shall be vested with the powers and duties necessary for the administration of the affairs of the Section and perform duties assigned to it by the Board of Governors.

4.2 <u>**Composition**</u>. The executive committee shall be composed of the following person:

- (a) The officers;
- (b) The Immediate Past Chair; and
- (c) Nine members elected as At-Large members to the executive committee.

4.3 <u>**Controlling Vote**</u>. A majority of the executive committee constitutes a quorum needed for action. Action of the executive committee shall be by majority vote once a quorum has been established.

4.4 <u>Meetings</u>. The annual meeting of the executive committee shall be held in conjunction with the annual meeting of the Section. Special meetings shall be held at the time and place as may be designated by the Chair or a majority of the executive committee. The executive committee shall be expected to conduct a minimum of four meetings annually.

ARTICLE 5. Officers

5.1 <u>Officers</u>. The officers of the Section shall be the Chair, the Chair-elect and the Secretary/Treasurer.

5.2 <u>Chair</u>. The Chair shall preside at all meetings of the Section and of the executive committee. He/she shall formulate and present at each annual meeting of the Bar an annual report of the work of the Section for the then past year. He/she shall perform such other duties as usually pertain to his/her office or as may be delegated by the executive committee.

5.3 <u>Chair-elect</u>. Upon the death, resignation, or during the disability of the Chair, or upon his/her refusal to act, the Chair-elect shall perform the duties of the Chair for the remainder of the Chair's term except in the case of the Chair's disability, and then only during so much of the term as the disability continues.

5.4 <u>Secretary/Treasurer</u>. The Secretary/Treasurer will take minutes at each meeting of the Section and executive committee and provide them to the Bar for publication and record retention. The Secretary-Treasurer will work with the Bar to ensure that the Section complies with Bar fiscal policies and procedures, work with the Bar to prepare the Section's annual budget, and review the Section's monthly financial statements for accuracy and comparison to budget. In conjunction with the Chair and as authorized by the executive committee, he or she shall attend generally to the business of the Section.

ARTICLE 6. Elections

6.1 **Elective Offices**.

- (a) <u>Officers</u>. The membership shall elect a Chair-elect and a Secretary/Treasurer to serve a one-year term.
- (b) <u>At-Large Members of executive committee</u>. There shall be nine (9) At-Large members of the executive committee. Three (3) At-Large members are to be elected each year. Of the At-Large members, one third (1/3) of should be from Eastern Washington and two thirds (2/3) should be from Western Washington. The length of terms for At-large members shall be three (3) years.

6.2 <u>Chair</u>. The Chair-elect shall automatically succeed to the office of the Chair. If the office of Chair-elect becomes vacant, then a Chair shall be elected in the same manner as set forth in Section 6.1 above.

6.3 <u>Nominations</u>. The Chair shall annually appoint a nominating committee of not less than three (3) members of the Section not members of the executive committee, which committee shall make and report nominations to the executive committee for the offices of Chair-elect, Secretary/Treasurer, and At-Large members of the Executive Committee to succeed those whose terms will expire that year, and to fill vacancies then existing for unexpired terms. The executive committee will approve a list of nominees for each open position.

6.4 <u>Voting</u>. Nominations and elections for open executive committee positions will be held between March and May each year. The Bar will administer the elections by electronic means and certify the results, unless the Section develops its own equivalent electronic election process. In the event of a tie, the Executive Committee will implement a random tie-breaker of its choice, such as a coin toss, to determine the winner.

6.5 <u>**Term of Office**</u>. All executive committee positions will begin October 1 each year.

6.6 **Interim Appointments**. In the event of a vacancy during the interim between annual meetings, the executive committee shall appoint, by a majority vote, a successor to serve until the next annual election when an individual will be elected to serve the remainder of the vacated term.

ARTICLE 7. Substantive Responsibilities

7.1 <u>**Committees**</u>. The Chair may appoint committees to perform such duties and exercise such powers as the executive committee may direct.

7.2 **Budget Committee**. The duties of the budget committee are to prepare a proposed budget in consonance with the objectives of the Section for the expenditure of the Section funds.

ARTICLE 8. Amendments

These bylaws may be amended at any annual meeting of the Section by a majority vote of the members of the Section present and voting, or at an executive committee meeting by a majority vote of the voting executive committee members once a quorum is established, provided that no amendment shall become effective until approved by the Board of Governors of the Bar.
