 - i. \$90,249.04 in reserves
 - ii. Currently at 860 members this year (and on track for the 984 we had last year)

a. Annual Institute

i. Chairs: TS & KZ

ii. Date: April 19, 2018

- iii. Title: The 23rd Annual Intellectual Property Institute: Where is the value of U.S. Intellectual Property headed?
- iv. Attendance / Revenues:
 - 1. There were approximately 85 attendees, both in person and online.
 - 2. Ultimately that means there were approximately, 78 paying attendees, with total revenue of around \$23010.
 - 3. This means ultimately the Annual Institute will likely be one or two thousand revenue negative.
 - a. Reason 1 = Motif was more costly venue. Although costly, it was a very nice venue.
 - b. Reason 2 = INTA and AIPLA spring meetings happening now.
 - 4. Annual Institute will also be test case for new revenue sharing model (see below).
 - 5. End result = Annual Institute's status as a or the premier IP CLE in Washington strengthened. Costs and attendance will remain key concerns moving forward.

v. Highlights:

- 1. Feedback was overwhelmingly positive.
- 2. Director Molly Kozcialski gave a very good keynote speech.

7. Spring Leaders Meeting:

- a. TS and KZ remotely attended the Spring Leaders Meeting on April 25, 2018.
- b. New WSBA President Bill Pickett started session with surprising implied proposal that Sections split off an become independent 503(c).
 - i. Bar Staff and Section Leaders in attendance were, almost without exception, surprised and opposed to the proposal.
- c. Other Highlights:
 - i. May be adjustments to Listserve technology (WSBA investigating)
 - ii. May be adjustments to whether elections must occur between March and May
 - iii. Revenue Sharing Proposal is advancing towards vote with Bar Leadership
 - 1. Reason for change is across the board drop in live attendance, since live attendance requirement was removed in January 2016
 - 2. Plan:
 - a. First \$8000 in net revenue will be split 50/50 between WSBA and Sections
 - b. After \$8000, the split will be 65% to WSBA and 35% to Section
 - c. Revenues include online product sales for three years
 - i. We will have good understanding of online product demand for Annual Institute at the end of this year
 - d. Under all projections so far, this proposal is more advantageous to Sections than current system

- e. Only drawback is that revenues will be distributed on a yearly basis rather than in the two or three months after CLE
 - i. Our Section should be able to weather the initial lag in revenue attribution, given size of reserves
- iv. Materials from Spring Leaders Meeting are attached
