 - iii. NOTICE REGARDING LICENSE FEE ROLLBACK PETITION:

On Jan. 5, 2017, the Washington Supreme Court entered an order affirming 2018, 2019, and 2020 license fees approved by the Board of Governors at its Sept. 29, 2016, Board meeting. In addition, the Court stated that if such current license fee rollback petition were to pass, the license fee proposed by the petition, as well as the requirement of tying future license fee increases to the consumer price index would not be reasonable.

At its Jan. 26-27, 2017, Board meeting in Spokane, the Board of Governors will discuss whether holding the referendum vote is appropriate in light of the Court's order given that a vote by the active membership to pass such a referendum would be moot.

- iv. JD: WA SC ordered that fees approved by BOG will stand; that the petition circulated was unreasonable and not operative;
- v. JD noted that he's received a few email from members; most common theme was optics of WA SC taking this action over will of a number of licensed attorneys;

- vii. IPEC engaged in discussion regarding the petitions, but IPEC did not take an official position;
- viii. JD: The attorney that started the fee reduction petition is now proposing that the BOG require all CLE's to be free;
- ix. JD suggested that the sponsor of the petition and possibly many signatories have not studied the full picture of the BOG budget;
- x. JD: At BOG meeting in Spokane in February, BOG will discuss next year's fiscal budget, which is a long process that provides a lot of opportunity for public (*i.e.*, bar rank and file) input.
