- XIII. Section Leader's meeting was held on April
- A. TS: Participated via webcast;
 - B. Discussion included:
 - i. WSBA is developing a new website;
 - ii. Electronic voting system is under development and will be fully ready next year, March 2018;
 - iii. Cannabis attorneys are considering pursuit of a cannabis-dedicated section;
 - iv. LPO's are considering pursuit of an LPO-dedicated section;
 - v. FY2018 begins October 1, 2017;
 - vi. Fiscal years will be coordinated with membership years;
 - vii. Ann Holmes summarized and discussed the WSBA budget process; section budgets are due July 14;
 - viii. Proposed budgets, which are prepared for opening discussion points, will be sent to section leadership on or before May 12;
 - ix. Sponsorship for alcohol at WSBA section-sponsored events is permitted, but there are details to work out including permission of the WSBA; best practice is to engage the WSBA as early in the process as possible;
 - x. JT discussed the Article 11 bylaw update process and current status;
 - xi. Several interactive breakout sessions were then conducted.
