It would be a privilege to continue to serve the Juvenile Law Section as the Secretary/Treasurer for 2024-2025. For over 17 years, I have devoted my legal career to the practice primarily to dependency law. I have also served the Juvenile Law Section as the Secretary/Treasurer for the 2023-2024 term, and as the Dependency and Child Welfare Committee Co-Director during the prior term. I believe my legal experience, and my service to the Section, will help me continue to work with the Executive Committee in making tangible differences for Section members and for the communities our Section impacts.

I currently work as a Managing Attorney with the Parents Representation Program at the Washington State Office of Public Defense. In this role, I manage the contracts of the attorneys who directly represent indigent parents, guardians, and legal custodians in dependency and termination proceedings. I provide technical assistance, approval for expert service funds, and referrals for social workers, experts, and other assistance to ensure that parents receive high-quality legal assistance in these incredibly crucial legal proceedings. Part of my duties and responsibilities involve managing two important programs that work to prevent families from entering the child welfare court system: I manage the contracts for our state's three pre-filing legal representation programs, and I manage the state's new Voluntary Placement Agreement Legal Consultation Hotline. I also have years of direct representation experience, both as a defense attorney representing parents and as an Assistant Attorney General representing the Department in child welfare cases. My current employment, and my past experience, familiarizes me with the types of critical issues our Section should be addressing. For example, this past year, I have worked with the Executive Committee to find and fund child welfare-related scholarship opportunities for Section members. I have also worked with the CLE Coordinator and other Executive Committee members to arrange a three-part mini-CLE series focused around the intersections between immigration and child welfare.
