## <u>AGENDA</u>

### 1. 21<sup>st</sup> Annual Labor & Employment CLE

• Location: Washington State Convention Center or Webcast WSBA is not willing to sign contracts at this time due to the pandemic. So that is causing an issue, but we'll pick a date.

#### • Date: Thursday, November 18, 2020 The week prior on Thursday is Veteran's Day and the following week is Thanksgiving week, so that week was chosen and there was debate about Thursday versus Friday.

### • Ideas for panels and speakers:

- We should have a judge and an ethics panel. Judge Erlick is well-liked and received good reviews. Now doing arbitration and mediation and WANs so may be easier to schedule. (There are currently five federal judge positions open, so it is anticipated we will have some new appointments.) Brad will reach out to Judge Erlick.
- Wage and hour issues we did a lot of paid family leave, but there were issues here were changes regarding salary limits.
- Remote working and issues: tax implications, multi-state issues and worker comp, etc.
- DOL new final rule to clarify independent contractor status under FLSA
- Revisit issue of employee speech outside of work/off duty conduct

#### 2. 2021 Mini-CLE Ideas

- **Topic: Vaccines and Employment Issues** Brad motioned and Jillian seconded. It was unanimous that we should do a CLE on this topic.
  - Recent EEOC guidance says it can be required, but there have to be accommodations for health conditions that make it dangerous, religion, and "strongly held personal beliefs", and then assess risk to others.
  - Workers comp (if employers sponsor),
  - Work time for the vaccine
  - How employers might sponsor it
- Volunteers:
  - Tech/CLE person: Angle or Kelli
  - Organizers: Jillian will reach out to Jamal Whitehead for an EEOC connection. Brad can help organize but may not be a moderator, Kelli will look at EEOC contacts.
  - $\circ$  Moderator: let's see who our speaker is and who has the best relationship with them.

## 5. <u>L&E Executive Committee Officer Terms and Election</u>

- Our bylaws provide that officer terms run October 1 to September 30, which coincides with the Bar and other sections. Our Exec Comm has been electing officers to serve calendar year terms (Jan 1 to Dec 31). Exec Comm needs to decide whether to amend bylaws or change timing of Exec Comm officer elections. A copy of current bylaws is attached.

**Per Bylaws, Article VI, 6.1.b. Elective Offices.** Officers. Nominations and elections for open officer positions will be held between March and May each year. Officers serve a one year term in the specified office and shall serve simultaneously as executive committee members. The executive committee may nominate officers from the existing executive committee or officers may be nominated in an alternative process; however, any person not already an elected member of the executive committee must be elected to the executive committee through its ordinary procedures before serving as an officer.

6. At-Large Elections – per Bylaws, Elective Offices.

We have an opening on our Group 2 for our Public Sector Defense Counsel position, so we need to make an interim appointment.

**Per Bylaws Article VI, 6.5 Interim Appointments.** The executive committee will appoint, by majority vote, members to fill vacancies on the executive committee. When a member is appointed to fill a vacancy in an unexpired term, the member will do so until the next annual election when an individual will be elected to se rve the remainder of the vacated term.

**Per Bylaws Article VI, 6.1.a., At-Large Executive Committee Members.** Nominations and elections for open At-Large executive committee positions will be held between March and May each year. Each of the thirteen elected positions on the executive committee shall be for a three-year term with three positions expiring each year.
