- Meeting was called to order at 9:07 a.m.; quorum established
- September 2024 meeting minutes approved
- Cassie welcomed new EC members; it is exciting to have four new Committee members and a full Committee for the first time in a while; explained that she would send around a survey to determine whether there needed to be a new meeting day and time
- Cassie noted that she was working on the 2024 Section Annual Report and would submit it by the due date of October 11, 2024

- 3:45 p.m. -- The Future of DEIA in the workplace Following Students for Fair Admissions v. Harvard

 - Moderator: Jess
 - Jess was not present to provide an update, but Cassie had information to share; this panel was just finalized the week prior and panelists were meeting this week to prepare outline and talk about materials; one of the panelists will fly in from D.C.
- Angie volunteered to coordinate speaker gifts; she would like to get them out soon after the conference; each moderator is responsible for getting address information to Angie ASAP; there is a budget of \$100 all in for each gift
- Budget update: Matt noted that we don't have the September report yet, so the numbers he has are current as of August; we are right on track for budgeted expenses for the year; August balance was \$166,066.82 and after expenses, \$92,966.18
- January Breakfast meeting:
 - Cassie explained that we should start planning this now since we have the holidays coming before the January meeting
 - Andrea volunteered to coordinate; she will send out a Doodle poll for a Tuesday-Thursday in the second or third week of January; Cassie suggested a 9:30 or 10:00 start time to try and avoid some traffic for those who have to commute
- Mini-CLEs ideas:
 - We have held three mini CLEs this year and it is not likely we will have time for more
 - Cassie noted that we have two ideas already lined up for our next mini CLEs
 - o Cassie has been coordinating with Kelby Fletcher for an appellate update
 - Fallon let Cassie know that she would like to have a mini CLE on legal & organizing strategies in the gig economy
 - Topic: Due to non-traditional models for workers' rights that have been created to respond to the gig economy/independent contractors. Teamsters

Local 117 was integral in supporting the creation of a separate organization called the Drivers Union which was founded to provide passenger drivers who work for app-based transportation platforms (Uber/Lyft) to have a voice and deactivation protections. This is one of the first organizations of its kind. Passed Legislation in the City of Seattle that brought drivers fair apay, sick time, and deactivation protections. Replaced recently by a new state law that expands those protections to drivers across the state, despite the drivers not being considered traditional "employees". Washington serves as a model for states across the country trying to provide similar rights to drivers.

- Potential presenters: General Counsel of the Drivers Union, she could speak to the policy/legislation side of the work

- Carolyn introduced herself to new members she is the staff liaison between all sections and WSBA; she welcomes all questions and is here to help support the sections
