Recent events in the United States and worldwide call into question any feeling we may have had that the legal rights of women - who constitute more than half of humanity - are continually improving. Armed conflict, erosion of democracy, and a rise in extremism are degrading the legal and practical rights of women in many places.

What are the facts? What are the laws? What is the way forward?

Please join us as Dr. Elizabeth Zechenter, visiting scholar at Emory University, provides a one-hour survey of this essential topic.

## Speaker Bio:

Dr. Elizabeth M. Zechenter is an international attorney, social scientist, academic researcher, and frequent public speaker. She is currently a visiting scholar at Emory University. Zechenter holds a Ph. D. in evolutionary archaeology and a J.D. in American law. She has taught international law and human rights law at Georgetown University Law Center and worked as Assistant General Counsel at GSK.

Zechenter's research interests include the rule of law, the theory of human rights, as well as evolutionary theory and the development of social complexity. She is the author of numerous articles and books, including "In the Name of Culture: Cultural Relativism and the Abuse of the Individual" and "The Socio-Economic Transformation of Poland: Privatization and the Future of Environmental Protection."

She is a passionate advocate for human rights, and her work has made a significant contribution to the field.
