CLEs

- Recap on July webinar on Quebec: speaker was very thorough; around 20 participants
- Recap on August webinar on Catalan self-determination: good program but the presentation was one-sided. This was intentional because it was a perspective that isn't often heard. Maybe we can arrange a future program to hear the other side of this debate? The speaker could have provided a bit more of a roadmap of the presentation and submitted his presentation materials a bit sooner (so that there was time to make sure the presentation was the right length, etc). Good to keep in mind that lawyers from different countries present information differently. In many cases, our CLEs don't present both sides of an issue because that isn't the point. Instead, it's to share a lesser-known perspective or to ask experts to share their particular expertise and perspective.
- Scotland seminar update: Regina sent out a preliminary listserv message today about this. She will be applying to WSBA for program CLE accreditation. Program includes a wide range of topics, including race issues in Scotland. Registration is open. Program is entirely virtual. It will be recorded so that people can watch when most convenient. Eleen can post information to the WSBA website.
- "Listen in" conversations: first one on Black Lives Matter was excellent! COVID-19 one was also great and Regina encourages us to watch the recording to get our thoughts on some controversial issues/perspectives that came up.
- Anne working with Dwight on October CLE

- Regina will be scheduling the next listen-in for October. Thinking of a couple university professors. Looking for moderators so let Regina know if you're interested!
- Anne working on setting a date for November CLE
- December: space law (speaker is overseas)
- January: trauma/human rights violations
- February: Climate Defense Council on climate change movements
- CLE's have been scheduled out until February 2021
