



2027 LICENSE FEE PAYMENT PLAN FOR LICENSED LEGAL PROFESSIONALS

OVERVIEW

- As set forth in the table below, you may pay your 2027 license fee in up to five monthly installments. To take full advantage of the plan, sign up and pay the first installment in October 2026.
- All payments are due by the first day of the month and the **balance must be paid in full by Feb. 1, 2027.**
- The 2027 [Client Protection Fund](#) assessment has been set at \$0 by the Supreme Court.
- Optional: You may take the [Keller deduction](#) or donate to the [Washington State Bar Foundation](#) (WSBF) and/or the [Campaign for Equal Justice](#) with your last payment.
- Mandatory: Online licensing opens in November. All [licensing requirements](#), including payment, must be completed by Feb. 1, 2027. A late fee will be assessed Feb. 2. Failure to comply with licensing requirements may result in a Supreme Court order of suspension (Supreme Court Admission and Practice Rule 17).
